

# **OFFICIAL RULES**

# 1. PROMOTIONAL SUMMARY

On Friday, May 30th, 2025, at 10:00 PM, 20 – Grand Prize participants will be selected to compete in the Grand Finale Drawing, where one (1) Grand Prize Winner will be awarded a brand-new preselected house. Participants qualify for the Grand Finale by winning a Friday Lucky Key Finalist qualifying drawing, by being one of the top three (3) point earners during the promotional period, or by being one (1) Social Engagement Winner<sup>1</sup>. All Grand Finale participants must agree to and sign the Official Rules and Winners Release prior to participating in the Grand Finale Drawing. Documents must be signed by 10:00pm on May 30, 2025. Failure to sign release documents will result in immediate disqualification.

### 2. HOW TO ENTER

#### **Promotion Period:**

- Start: 12:01 AM on March 1, 2025
- End: 9:30 PM on May 30, 2025

#### Entry Methods

- Earn entries by playing slot machines or tables while using a valid Pechanga Club card.
  - $\circ~$  1 Entry will be awarded for every 10 base points accumulated.
- Activate entries on drawing dates between 5:00 PM 9:30 PM by:
  - Inserting a Pechanga Club card into any slot machine
  - Having a rated table session closed during the activation period
- Activation does not require additional actions such as kiosk swipes or purchases.
- There is no limit to the number of entries you can earn during the Promotion Period. However, all entries are subject to eligibility and participation requirements outlined in these rules.

# 3. HOW TO EARN ENTRIES

- Slots & Table Games: Use a valid Pechanga Club card during play.

## 4. HOW TO QUALIFY

#### Friday Lucky Key Finalist Drawings:

- Held each Friday from March 7, 2025 May 23, 2025.
- One drawing winner will secure a finalist spot each week.

#### May 30<sup>th</sup> Final Lucky Key Qualifier Drawing:

- May 30, 2025 at 9:30PM
- A minimum of four (4) winners will be drawn during this final qualifier drawing.
- Winners of the Lucky Key drawings on May 30<sup>th</sup> are not eligible for \$5,000 cash prize awarded during previous weekly drawings.

#### Top Point Earners:

 Three (3) players who accumulate the most points from rated play between March 1 – May 23, 2025 will qualify as a finalist.

#### Social Engagement Winner

- One (1) winner will be selected through a social media campaign.
  - Winner must enroll in or already be a member of The Club at Pechanga to participate.
  - Nine (9) on-property challenges will be announced to earn a predetermined One new challenge will be announced each week 3/8/25 – 5/9/25
- Participants can earn additional entries by engaging in Friday LIVE videos on social media.
- Social Engagement participants must activate their social drawing entries by inserting their club card into any slot machine at Pechanga Resort Casino at least once between March 1, 2025, and May 9, 2025.

- After 10 minutes the \$5,000 prize will be forfeited and the winner will have 48 hours to claim their finale spot.
  - After 48 hours the finale spot will be forfeited.
- Weekly Finale Spot Winners may only claim one finale spot during the promotion.

### 6. GRAND FINALE DRAWING

#### Event Details:

- Time: 10:00 PM
- Location: Promotional Area at Round Bar

#### Process:

- All twenty (20) finalists will each have one (1) entry in a raffle drum.
- Finalists will select a key in the order their names are drawn.



- Prizes will be revealed when the keys are "opened":
  - o 17 Keys: EasyPlay prizes
  - 3 Keys: Advance to the final round

#### Final Round:

- Three (3) finalists will open an additional item to reveal their prize.
- One (1) Winner will win the Grand Prize of a new house
- Remaining Two (2) Winners will win cash prizes.

# 11. HOW WINNER WILL BE DETERMINED

# **12.CONDITIONS OF ENTRY**

Tampered or altered entries are void. ### 13. GRAND PRIZE DETAILS

One (1) Ultimate grand prize winner will receive a brand-new preselected house built by Meritage Homes in the Prado Community of Temecula, CA, with an approximate retail value of \$723,258.64 The specific model, features, and specifications of the house will be determined solely by Pechanga Resort Casino. The prize is subject to availability and Pechanga Resort Casino reserves the right to substitute a prize of equal or greater value if the specified house becomes unavailable for any reason. The purchase price of the house will be paid for by Pechanga Resort Casino.
